Two River -- D.N.R. would like to have a September 1, 1979, start on the Mereson Project, but due to the lack of a permit and incomplete engineering at this time, it is questionable whether this would be possible.

Red Lake - Last River Impoundment bids were let on an hourly basis with the total cost estimated at \$125,000.00. The revised amount pledged by L.R.R. -

L.C.M.R. funds 462,500.00 L.R.R. ''22,500.00

Sand Hill- A discussion was held' with some members of the Water Resources Board on Sand Hill Project §1, Technicalities were the subject of discussion and it was agreed that they could be resolved without problems.
