The Watershed District is in agreement with the SWCD in addressing erosion control within the district, splitting the cost with SCS at 75% and the Red Lake Watershed District at 25%.

Wild Rice Watershed District

Sundal Project #35

Is a multiple pool project with eight pools.

Project #36

Is scheduled for spring 1989 construction.

Project #37

Need to acquire land rights.

Sand Hill Watershed District

The District is in the final stages of working out problems with the Pollution Control Agency.

Buffalo-Red River Watershed District

The lateral on Ditch #13 is complete.

Bjornson #13

The North Dam is complete and the South Dam will be completed in 1989. The flood control portion is in place.

Stinking Lake #16

Next step is the Engineers Report. It should be read for funding in 1989.

Donley #9

Soils are a problem at the site.

Joe River Watershed District

The building of the dike at Noyes has been stopped because of frozen ground.

Upon motion, second and duly carried, the reimbursement to St. Vicent Township in the Joe River Watershed District was ordered paid.

Redetermining the benefited area in Richardville may help in deciding what to do.

The Wild Rice Watershed District requested 50% funding assist; from the LRRWMB for the installation of gauge stations at Hendrum and Shelly. The Sand Hill Watershed District made the same request for gauge at Climax, as well as the Buffalo-Red River Watershed District on the South Branch of the Buffalo River at Sabin and the Red Lake Watershed District on the Lost River at Oklee.

Upon motion by Manager Person, seconded by Manager Ward for the LRRWMB to assist the named watershed districts with 50% funding on \$72,500.00 for the five gauge installation, carried by a six to two vote.

By previous commitment with U.S.G.S. for the maintenance of stream gauges from October 1, 1987 to September 30, 1988 for \$26,710.00 was ordered paid. The local districts in turn pay the LRRWMB 50%.

Upon motion by Manager Nelson, seconded by Manager Bowen for 1 maintenance of stream gauges with U.S.G.S. for the period October 1, 1988 to September 30, 1989 for \$28,500.00, duly carried.

Dan Thul asked that the LRRWMB adopt a resolution to support c long term State commitment on stream gauging and the D.N.R. and Legislative proposal for a cost share program.

Upon motion by Manager Quern, seconded by Manager Nelson to adopt the resolution for the LRRWMB's support, duly carried.

The next meeting will be a joint meeting to be held with the North Dakota Joint Water Resources Board at the Holiday Inn at Grand Forks, North Dakota on January 11, 1989. The Lower Red River Waters Management Board will meet at 9:00 a.m., with the joint meeting to held after the noon meal.
