The Technical Committee for Drainage Systems Analysis held their first meeting last week.

The Technical Committee for the Six County Group met with the Corp. of Engineers to discuss the survey work to be done. The LRRWMB has committed \$15,000.00 for the survey. A meeting was set up for next month to complete the data obtained by the survey.

## Project Reports:

### Wild Rice Watershed District

Projects #35 and #37

There is a peat problem where the dam is to be located. Clay will be needed to correct the situation. They are checking now, to see what the additional cost might be.

### Middle River-Snake River Watershed District

They asked if the funds from the State Flood Damage Reduction Program could be transferred from the LRRWMB to the Middle River-Snake River Watershed District when received.

On motion by Manager Nelson, seconded by Manager Quern to transfer the funds when received, carried.

### Buffalo-Red River Watershed District

The Bjornson WLMA #13 project has been completed. The Hampden Slough Refuge dispute has been resolved.

# Sand Hill Watershed District

Phosphorous levels are being checked on the Winger Dam project.

### Red-Lake-Watershed Pistrict

Have obtained an agreement on Good Lake. Will open bids on July 27, 1989.

### Roseau River Watershed District

Held a meeting on the Roseau River Diked Storage project and it went quite well.

### Joe River Watershed District

A profile of the district is being done. They should finish the Noyes Dike in 1989.

## Red Lake Watershed District

A hearing on Maple Lake will be held on July 27, 1989.

A Step I feasibility Study is to be done on the Upper Clearwater Flood Control Project is to be done at a cost of \$5,000.00 and the LRRWMB was asked for one third of the cost or \$1,666.65. On motion by Manager Nelson, seconded by Manager Quern to fund their request for \$1,666.65, duly carried.

A discussion on the two mill levy was held and a 20% reduction of the levy was suggested. On motion by Manager Nelson, seconded by Manager Ward to adopt a resolution to set the levy for 1989 at .0384 per cent of the estimated market value in the districts, duly carried

It was reported that the Extension Educator position has been filled. Also that Robert Runkel is leaving his position and that part of his work load may revert to Dan Thul. There will be one other new position created, but a further break down of work load must be done before comments pro or con can be made.

The Bois de Sioux Watershed District was issued an invitation to attend the LRRWMB meetings obtain any benefits the LRRWMB can provide.

Further discussion was held about a regular meeting date for the LRRWMB. On motion by Manager Ward, seconded by Manager Person to set the monthly meeting date on the third Tuesday of each month, carried.

The next meeting will then be held at 9:00 a.m., August 15, 1989 at the Wild Rice Watershed District office, Ada, Minnesota.
