Meeting: Lower Red River Watershed Management Board December 19, 1989

The Lower Red River Watershed Management Board met on December 19, 1989, at 9:00 a.m. at the Seminar Room, U. of M., Crookston, Minn.

President Don Ogaard called the meeting to order.

Minutes of the November 21, 198 9 meeting were read and approved. The

Treasurers report as of December 19, 1989 was accepted as read.

The Chairman asked about the joint meeting that we usually have with the North Dakota Joint Water Resources Board in January. He suggested a topic of Canadian participation in U.S. activities, with the subtopics being:

- 1. What are you doing now?
- 2. What would you like to have us do?
- 3. How can we cooperate with each other?

Lance Yohe was going to call some Canadian friends and; see what he could come up with. A suggested meeting date was January 16, 1990, with the meeting place being in Grand Forks, ND at whatever location is available.

Lance Yohe of the International Coalition reminded the Board that membership for 1989 and 1990 have not been committed. After discussion, Manager Wilkens, seconded by Manager Osowski to become a member of The International Coalition for the years 1989 and 1990 at \$500.00 per year, duly carried.

He also asked for support by resolution to endorse two funding applications to the Minnesota Board of Water and Soil Resources by The International Coalition. One grant request is for funding of a cooperative program with the Red Lake Watershed District, U. of M., Crookston, Minnesota and The International Coalition to relate Land Use/ Water Quality on the Clearwater River. The other grant application is for providing education services to Counties, Watershed Districts and Soil and Water Conservation Districts for use of the Geographic Information System (GIS) developed during the water planning process. Upon motion by Manager Wilkens, seconded by Manager Bowen to adopt the Resolution, duly carried.

Dan Thul reported that the cooperative stream gage payments are due for the period October 1, 1989 to September 31, 1989. He also discussed the obligated fund balance of the LRRWMB as of December, 1989. Upon motion by Manager Bowen, seconded by Manager Osowski for those projects now in a hold position, namely the Karlstad Project, Wild Rice #37 and Hay Creek #6 be dropped for now and if the projects become active again, they may be re-submitted to the Board, duly carried.

He reported that the Technical Committee met on December 8, 1989 at Moorhead, Minnesota discussing the TIC project through LCMR. The purpose of the Project is to develop the linkage between the Geographic Information System (GIS) and a standard watershed model. The Technical Committee received work that has been done to evaluate the potential flow reduction benefits of various projects. Technical criteria for evaluating proposed projects was discussed. One method is referred to as the Star Value. It could be a good tool that would define LRRWMB funding up front to achieve maximum mainstream benefits

District Activities Report:

Wild Rice Watershed District

The District is involved with the Corp. of Engineers on cleaning and snagging on the Wild Rice River. On the series of eight 3ams, two of the proposed dams will be gated and the dams that were completed this year could be gated. The Becker Dams may be gated too, be possibly tried for one year. Two Rivers Watershed District

An information meeting was held on December 6, 1989 and it was well received.

Buffalo-Red River Watershed District

On Buffalo River Site #1 (formerly Donley #9) easement options are being secured and an information meeting went well. On Stinking Lake they are working on two dams. An information meeting on Deerhorn Creek #22 is scheduled in January. They are also working on the Overall Plan.

Middle River-Snake River Watershed District

Two more Townships approved ring diking. They are having trouble selling Ditch #75 to the local people, they feel it is to expensive.

Red Lake Watershed District

The first bid letting on Good Lake could not be accepted because of a bonding problem. The second bid letting has been accepted.
