-Marsh Creek, Project #11 - This has been changed to gated design.

- FEMA work - \$500,000 to \$600,000 \$250,000 to \$300,000 additional monies for correcting erosion on Wild Rice River

Middle River-Snake River Watershed District

-The survey of roads along the Red River is finished. -FEMA work should be completed this week. -Two ring dikes were finished recently, four total.

Buffalo-Red Watershed District

-Construction has started on Stinking Lake #16.
-Overall plan is on hold.
-Presented final project costs on Bjornson Flood Detention and Stony Creek Flood Detention.
Bjornson Flood Detention - \$678,896.86
Stony Creek Flood Detention - \$515,536.38
-Donley Detention - mitigation with landowners.
-Deerhorn Creek - is in the study stage; doing survey work now.

Red Lake Watershed District

-A lot of good things are happening with the Comprehensive Water Planning.
-The last phase of the Elm Lake Project is being completed.
-Work on the first phase of Burnham Creek is being completed.
