Minutes of the May 21, 1991 meeting were read and approved.

The Treasurer's report as of June 18, 1991 was approved as presented. The Treasurer also reported on the conference put on by the State Auditor's office that he attended at Bemidji. He stated that in the future it would become necessary to deduct 6.2% for social security and 1.45% for medicare of the manager's salary.

The Chairman congratulated the Buffalo-Red River on an excellent tour that they sponsored, on June 7, 1991. They visited four basic projects: three water retention projects and a county ditch system.

The Winger Dam project was discussed - should there be Technical Committee involvement? Dan Wilkens stated that he and Roland Gullekson met with Dan Thul and Jerry Paul in Bemidji on the E.I.S. statement and the mitigation issue.

After discussion, a motion by Manager Wilkens, seconded by Manager Bowen that the Red River Watershed Management Board become directly involved with the Sand Hill Watershed District on the Winger Dam, duly carried.
