Dan Thul Report

Dan has been preparing for presentation relating to water supply for the TIC annual conference. An updated map showing retention areas will be presented as well as summary sheets for each site identifying the available storage.

Dan reported that an assistant Hydrologist I was recently hired to help pick up some of the permit work load he has assumed.

District Reports

Sand Hill -

Re-submitted the Winger Dam Project as a dry-dam.

Middle River - Snake River Watershed District -

The WSD has been coordinating the work plan for the Snake River Stream Maintenance Project with the DNR fisheries Section. The DNR grant through the County is for \$18,000.

Buffalo Red -

Flood Control Site No. 1 - plan modified so gates will only be closed for floods of a 5-year event intensity or greater. Easements being drafted for upstream channels and flood pool buffer strips (Dr. Clambey mitigation plan). Information hearing to be held November 30, 1992.

Buffalo River Erosion - Agreement made with Clay County, SCS, Corps of Engineers, SWCD, and landowners for demonstration erosion protection project. Estimated project cost is \$95,000.

Minnesota Conservation Corps and the District are working on a program to clean-up dump sites along the river channels.

Roseau River

Will have a Step I proposal on the Lost River Project in December.

Red Lake Watershed District

Minnesota Conservation Corps' crew began work of cleaning and snagging trees on Clearwater River.

Thief River Project, RLWD No. 99 riprap is one-half completed, completion date sometime next spring.

Awaiting hearing date on Maple Lake Project, RLWD No. 19 on the denial of water's permit.

Approval received for Work Plan and the amendment for additional funding from MPCA for RLWD Project No. 82, Clearwater Nonpoint Study. The Red Lake Watershed District offered a resolution on Examining Environmental Ownership that they are going to present at the annual MAWD meeting in December. On motion by Manager Ross, seconded by Manager Nelson to support the resolution as offered by the Red Lake Watershed District to tl MAWD annual meeting, duly carried.
