## Roseau River Watershed District

Will be holding meetings on constructing a ditch that will bypass the City of Roseau on the West side.

## Red Lake Watershed District

Progress is continuing on the Good Lake Project. A contract was awarded to Zaveral Brothers.

Have had beaver control meetings and are working on a joint powers agreement.

Had meetings with the Attorney General on the appeal of the decision on the Maple Lake Improvement.

Have met on a couple of ditch petitions.

Still appealing and clarifying District's permit on Judges ruling on the Burnham Creek lawsuit.

#### Buffalo - Red River Watershed District

An improvement petition was filed by landowners for improvement on Clay County Ditch #2. The field work is completed and the preliminary plan is being prepared.

A meeting with the Township and County on the Deerhorn Creek Retention was held in early January.

The Multi-Bloc site on the Buffalo River Stream Bank Demonstration Project was completed in December. The project consisted of approximately 200' of retaining wall built from recycled tires.

An aerial survey revealed 30-40- relatively large log jams exist from the outlet of the Buffalo River to Hawley, Minnesota. The BRRWD applied to S.C.S. for federal assistance under the Emergency Watershed Protection program to perform clearing and snagging on this reach of the river. The BRRWD was awarded approximately \$150,000.00 for the work. A public hearing was held on January 10, 1994. There was no opposition to the project. Wild Rice Watershed District

Are preparing an Engineers Report on an ice removal study.

#### Joe River Watershed District

Studying a diversion ditch on the West Side' of the Watershed.

#### Dan Thul Report

Has received a letter from the Division of Forestry on how they plan to treat, "Burning on Ice" for River Snag Removal Projects. This is in regards to DNR assumming the responsibility from MPCA to issue burning permits.

Also passed out cost share payment due for U.S.G.S. stream gages.

#### Policy Committee

Manager Ross stated that Larry Woodbury has the report pretty well completed. Will present it at the next meeting in February.
