<u>Motion</u> to approve and pay bills by Manager Deal, <u>Seconded</u> by Manager Money, <u>Carried</u>. For further reference, copies of the bills approved are attached hereto in the Treasurer's Report.

Budget and Tax Levy Rate Determination

Prior to discussion, Manager Wilkens requested his alternate, Phillip Swenson, participate in the discussion and vote.

- N. Goral distributed the 2016 proposed annual budget. The draft budget included projected expenses for 2016 based on a comparison of the previous year's actual vs. budgeted expenses.
- N. Goral distributed the Project and Program Commitments Worksheet as of June 30, 2015. Discussion occurred regarding board funding commitments to watershed district projects that are currently progressing through the step process.

The River Watch Program that the board participates in with the International Water Institute (IWI) was discussed. N. Goral distributed an amendment to the agreement between IWI and the RRWMB to extend the contract for another two-year term through May 31, 2016. **Motion** by Manager Holmvik

Page 3 July 21, 2015. Red River Watershed Management Board Meeting Minutes to authorize the amendment to extend the two-year agreement between IWI and the RRWMB for \$100K/year for another two-year term, **Seconded** by Manager Deal, **Carried**.

The board discussed the rural and farmstead ring dike programs. N. Goral circulated copies of board policies for cost-share on ring dikes that were adopted on May 18, 2010. R. Harnack added that the legislature approved a one-time appropriation of \$400,000 for rural and farmstead ring dikes that would be available until 2018. The board's current cost-share policies are as follows:

Rural Ring Dike Cost-Share:

BWSR/DNR Construction & Engineering 50%

RRWMB Construction & Engineering 25%

Remaining 25% - divided between the individual watershed district and landowner as determined by the local watershed district.

Farmstead Ring Dike Cost-Share:

EQIP Engineering 100%

EQIP Construction 75%

Watershed District 0-12.5% as determined by the local watershed district

Landowner 12.5-25% (RRWMB 0-25% of the total project cost not to exceed a combined EQIP and RRWMB cost-share of 75% of project costs upon request of the local watershed district)

<u>Motion</u> by Manager Deal to approve the 2016 proposed annual budget, <u>Seconded</u> by Manager Knott, <u>Carried</u>. Manager Money abstained.

The Board discussed the tax levy rate determination. It was moved by Manager Deal and seconded by Manager Carriere to maintain the levy at 75% (.0003627) for FY 2016. Upon roll call vote, the motion carried unanimously. Manager Money abstained. Phillip Swenson returned his position to Manager Wilkens.

Red River Retention Authority (RRRA)

K. Weston reported on the Regional Conservation Partnership Program (RCPP). The National Watershed Program Manual (NWPM) states that NRCS responsibilities provide for the State Conservationist (STC) offering overall management of the Watershed Program in his or her State and to provide for the coordination, organization, and management of program activities. K. Weston added that M. Podoll, North Dakota - STC has inquired about obtaining a waiver so sponsoring local organizations (SLOs) i.e. WDs/WRDs can start incurring costs prior to entering into project agreements with NRCS.

K. Weston noted that the RRRA has developed a screening tool that is required to be utilized by SLOs prior to entering into project agreements. The project agreements can proceed to the National Water Management Center (NWMC) for review following the final consultation of cooperating agencies such as the U.S. Army Corps of Engineers (USACE).

K. Weston referred to the Environmental Quality Incentives Program (EQIP) and noted that ~ \$45 million is still available this year to fund conservation programs in the basin. Manager Holmvik asked if these funds have been appropriated to the Red River basin. K. Weston responded that the original conservation funding stated that up to \$50 million a year over the next five years (\$250 million) was approved to minimize flooding, boost soil health, improve water quality and enhance wildlife habitat in the Red River of the North watershed. K. Weston

Page 4 July 21, 2015. Red River Watershed Management Board Meeting Minutes further clarified that the conservation funding states that each year up to \$50 million may be available through various NRCS programs which is not the same as an annual \$50 million dollar appropriation.

Manager Holmvik suggested forwarding a letter to Congressman Peterson requesting clarification on the funding made available through the efforts of the RRRA utilizing the RCPP via the 2014 Farm Bill. Manager Finney requested D. Thul to coordinate with R. Gjestvang and K. Weston in the development of a letter.

Water Quality Project Monitoring

- C. Fritz distributed the IWI Monitoring and Education Activity Report. The funding to sponsor the River Watch program in North Dakota schools has been secured for 2016 and 2017. The Red River Joint Water Resource District (RRJWRD) will continue to be the local project sponsor and will match NRCS funding 1:1. The Contribution Agreement covering two years has been executed for a total amount of \$96,600. The project start date is November 2, 2015.
- C. Fritz reported that a conference call was conducted with USACE regulatory staff on June 19th to discuss the Green Meadow Project Team (GMPT) Points of Concurrence (POC) Nos. 3 & 4. The memo developed in response to the conference call was distributed. C. Fritz added that the memo will also be discussed at the next Red River Basin Flood Damage Reduction Work Group meeting.

Scope of Work / Model Plan Development

- C. Fritz explained that last month the board authorized the development of a model plan to include a scope of work to merge the Accelerated Planning Process initiated in the Green Meadow watershed with the PL566 Small Watershed Protection Planning Process. C. Fritz noted that a meeting is scheduled tomorrow with J. Leitch, K. Weston, K. Ruud, R. Harnack, J. Bents and himself to finalize the model plan.
- C. Fritz stated that creating a template to ensure that plans submitted to NRCS meet state/federal requirements is the goal of merging the Accelerated Planning Process and the PL566 Small Watershed Protection Planning Process. J. Bents added that the development of a model plan that outlines the specific planning steps and information required by the federal government, including an economic analysis of the alternatives considered, will benefit watershed districts that plan to apply for RCPP funds.
- J. Bents suggested that since watershed districts have limited experience in developing watershed plans that meet the guidelines of the PL566 Small Watershed Protection Planning Process, C. Fritz and J. Leitch could provide assistance to each watershed district applying for RCPP funding by conducting the benefit-cost analysis.
- C. Fritz noted that in order to ensure federal cost-share funding is available, the local watershed plans must comply with the National Watershed Program Manuals (NWPM) which include economic analysis of various reasonable alternatives considered. C. Fritz added that although a SLO may find an alternative unacceptable, it does not eliminate it from consideration.

Project Coordinator Report

R. Harnack reviewed the Project Coordinator Report. State agencies have submitted information on bonding needs for next biennium. Member watershed districts were encouraged to submit their

Page 5 July 21, 2015. Red River Watershed Management Board Meeting Minutes updated project briefing documents based on the readiness for construction in years 2016, 2017, and 2018.

R. Harnack reported on the effort led by the Board of Water and Soil Resources (BWSR) and the Commissioner of Natural Resources (DNR) to study the feasibility of the state assuming administration of the section 404 permit program of the federal Clean Water Act. The study will identify the estimated costs and savings that would accrue to affected units of government, the effect on application review and time frames, and whether or not it would achieve the goals of regulatory simplification, efficiency, and reduced permitting times. The report must be completed by January 15, 2017.

Administrator Report

A) RRB Flood Damage Reduction Work Group

N. Goral reported that she has a meeting scheduled with H. Van Offelen to finalize the FY 2015 expenditures and reallocate the unexpended funds as directed by the Work Group at the June 16, 2015 meeting.

The FDR Communications Team met on June 26, 2015 in Detroit Lakes, MN to discuss a Communications Strategy for the Work Group. * Reminder: To those who haven't forwarded the FDR Communications Needs Survey, please send them to Rob Sip as soon as possible.

B) Public Information Committee Meeting

The Public Information Committee (PIC) conducted conference calls on 06/19/15 and 06/29/15 to discuss advertising for the vacated position of Public Information Consultant.

An advertisement for this position is currently posted for one month in the following publications: the Fargo Forum (print/online), the Grand Forks Herald (print/online), the Thief River Falls Times, and the Northern Watch.

Red River Basin Commission

- J. Lewis, Executive Director RRBC reported on the *Citizen Engagement for Voluntary Nutrient Management Strategies in the Red River Basin* effort. This program is funded by a Community Innovation Grant through the Bush Foundation.
- J. Lewis explained that the project was initiated since too much phosphorus and nitrogen is flowing into lakes and rivers which impacts how we use the resources. These nutrients are essential plant nutrients, however, in excessive amounts can lead to degrading water quality.

The project will focus in the southern portion of the Red River Basin which includes parts of MN, ND and SD and supports the current reduction strategies being developed in each jurisdiction. The project will couple strategies to simultaneously address both flooding and water quality problems.

D. Thul reported on the USACE Red River Basin Watershed Feasibility Study (WFS). A meeting is scheduled for Thursday, August 6th, to review an update of the Project Management Plan (PMP). The proposal to extend the Halstad Upstream Retention (HUR) modeling effort to the Canadian border to encompass the entire Red River basin will also be discussed. The RFP developed by Houston Engineering was forwarded to the USACE for review and the USACE has indicated they plan to utilize the recommendations to complete the project.

D. Thul noted that since additional federal funds were appropriated for the WFS, extra Work-in-Kind (WIK) credits from the Red River basin must be calculated. He plans to work with N. Goral and R. Gjestvang to update the WIK credits needed to match the federal funds.

District Reports

• The Wild Rice WD reported on the Green Meadow Project Team. The District notified the USACE that they plan to proceed with the Regional Conservation Partnership Program. The notification also requested clarification on the additional information the USACE is seeking on POC No. 3.

No requests for funds were submitted this month.
