RRWMB BOARD MEMBERS AND ADMINISTRATORS ATTEND CONFERENCE

WORKSHOPS FOCUS ON 'NO ADVERSE IMPACT' AND 'TOTAL WATER RESOURCE MANAGEMENT'

The Red River Watershed Management Board
(RRWMB) and the administrators from its affiliated
watershed districts recently
attended the 27th Annual
Red River Basin Land and
Water International Summit
Conference in Grand Forks,
ND. The Red River Basin
Commission sponsored conference included workshops
and seminars on the theme,
"The Changing Face of Flooding."

RRWMB President John Finney stressed the importance of attending seminars that provide new information about flood management issues. One important topic Finney and other RRWMB members have been learning about is how to protect property rights while also providing comprehensive flood damage reduction. Finney and RRWMB members Jerome Deal and Dan Wilkens attended a workshop titled: "No Adverse Impact-**Protecting Property Rights** for All."

No Adverse Impact (NAI) is defined as "an approach that ensures the action of any property owner, public or

private, does not adversely impact the property and rights of others," says workshop facilitator, floodplain manager and attorney Ed Thomas. "Part of an integrated and comprehensive water management plan is to acknowledge the rights of property owners and to ask ourselves if we can accept the consequences associated with at-risk development and its impact on others downstream."

For Finney, Deal, and Wilkens the workshop reinforced their commitment. and that of the RRWMB, to provide comprehensive flood damage reduction strategies that are just and fair. According to Wilkens, the RRWMB has "from its very beginning stressed mediation so that property rights are protected." For Deal, whose home watershed district is the Bois de Sioux Watershed District headquartered in the southern end of the Red River valley, the idea of total water resource management is the basic philosophy behind the RRWMB's basin-wide perspective. "In fact, what we do in the Bois de Sioux impacts

the entire basin. This is true of any watershed district up and down the valley," says Deal.

"Why is the work of the RRWMB and its affiliated watershed districts guided by a basin-wide perspective? Because it is the most fair and just perspective that protects the rights of land owners and citizens alike," says Finney. Attending the

conference and workshop on protecting property rights and total water resource management reinforced for Finney, Deal, and Wilkens that a basin-wide perspective is the best approach. "Not all watershed districts are on board with this basin-wide perspective, they've got to understand that a basin approach is the most fair and just," says Finney.

WATERSHED DISTRICT DEVELOPMENTS

ROSEAU RIVER WD

The Roseau River WD reported on the Hay Creek/Norland Project. Phases 1 and 3 of the project are nearing completion. Outlet structures for Phase 2 have been started and should be completed by July of 2010. The permit from the Minnesota Department of Natural Resources was approved. Bids should be let for construction this spring for the inlet structures and dike construction for Phase 2.

The District is planning two new ring dikes through the Environmental Quality Incentives Program (EQIP) and the rural ring dikes program with construction to begin this summer. Engineering for both ring dikes has begun and cost estimates are \sim \$120,000 - \$130,000 per dike.
